[Budgeting for college completion](#)

On February 7, the Illinois Board of Higher Education (IBHE) unanimously adopted a proposed higher education budget for Fiscal Year 2013, that implements a new state law ([Public Act 97-320](#)) requiring performance-based funding for community colleges and public universities. This serves as the first step in the implementation of performance-based funding, focused on the educational attainment goal of the *Illinois Public Agenda* with an emphasis on progress and completion of postsecondary certificates of marketable value and degrees, specifically among minority students and those who are academically or financially at risk.

The budget recommendations follow the “investment level” approach adopted by the Board in FY 2009, and utilized since then, with the intent that the investment steps present the Governor and General Assembly with additional options that can be accommodated at various levels of state funding. In the face of Illinois’ unprecedented fiscal crisis, the Board’s recommended level for Step One provides higher education with the same level of funding received in FY 2012. \$6.5 million (.5 percent) for public universities is reallocated from base funding and distributed based upon the performance funding formula. For community colleges, \$720,000 is reallocated from Base Operating Grants and distributed based upon a performance funding formula unique to the mission of community colleges.

At Step Two, the Board recommends restoration of funding to the FY 2011 level, which amounts to a 1.6 percent increase over FY 2012. The additional \$15 million for universities would be allocated using the performance funding formula. Steps Three and Four provide funding increases based on performance for public universities and community colleges, as well as for deferred maintenance needs. Funding is also recommended for various grant initiatives, the University Center of Lake County, and the Monetary Award Program (MAP) to improve affordability for needy students.

Governor Pat Quinn and Lieutenant Governor Sheila Simon joined business and education leaders on February 9, at an Illinois Pathways conference hosted by State Farm and the Illinois Business Roundtable to launch [the Illinois Pathways Initiative](#). The effort is an innovative public-private partnership between Illinois’ public education institutions and the business community to foster Science, Technology, Engineering and Math (STEM) learning. Funded through the State’s secured Race to the Top funds, Illinois Pathways will help prepare students for college and careers in new and growing fields.

“We have a mission in Illinois to ensure that at least 60 percent of adults have either a college degree or a career certificate by 2025,” Governor Quinn said. “Through this initiative, our state agencies will partner with the education

community and our business leaders to better support students and prepare them to graduate and get a good job in the 21st century economy.”

An interagency team, consisting of representatives from the Illinois Department of Commerce and Economic Opportunity, the Illinois State Board of Education, the Illinois Community College Board, the Illinois Board of Higher Education, the Illinois Student Assistance Commission, and the Illinois Department of Employment Security will set priorities and identify the first public-private STEM Learning Exchanges to launch in the fall of 2012.
